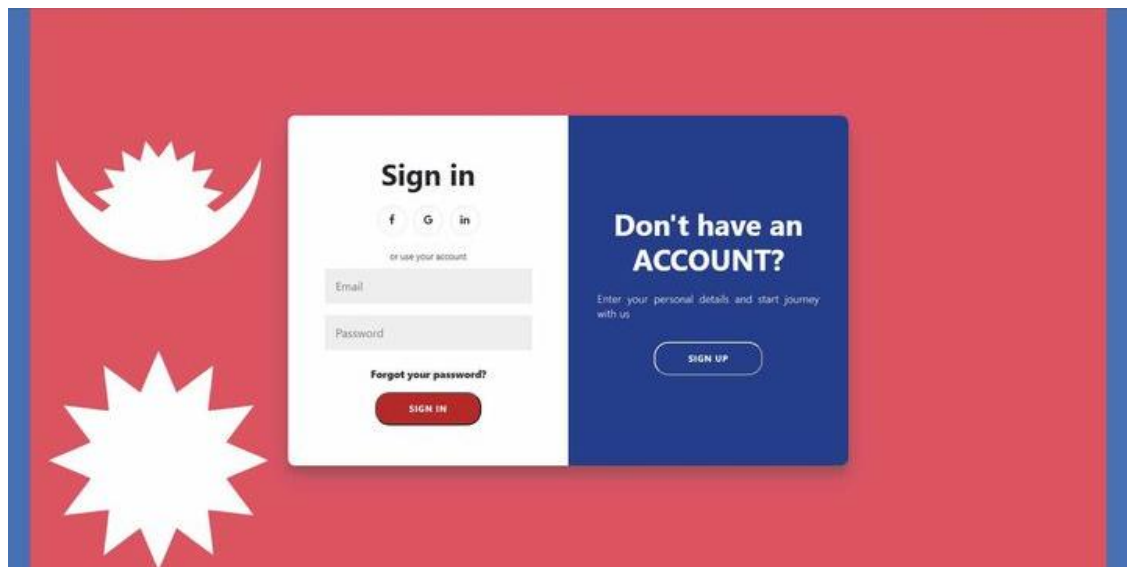

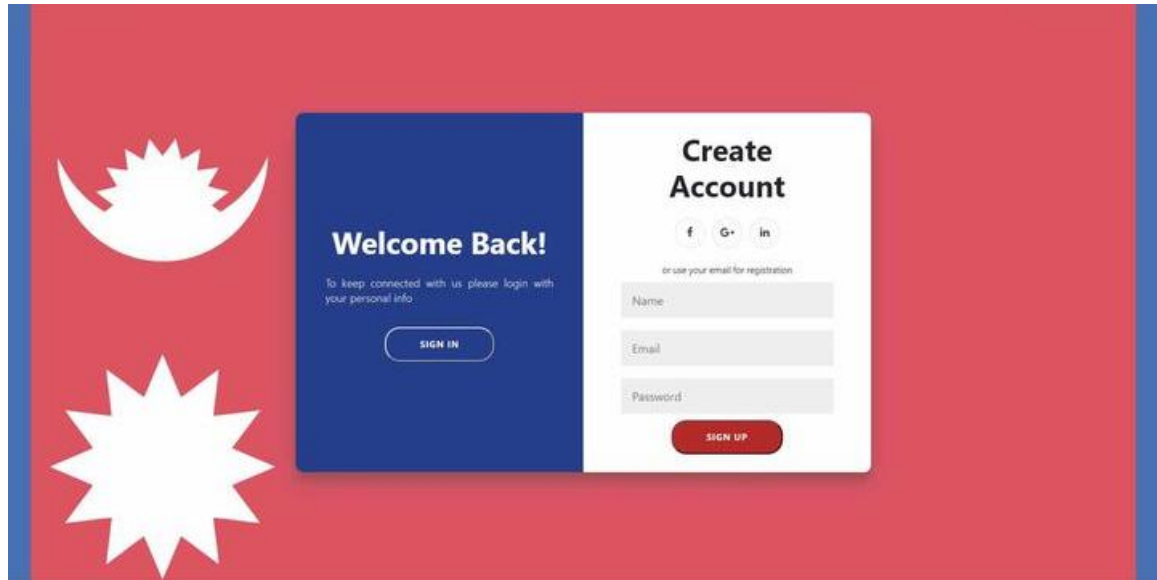

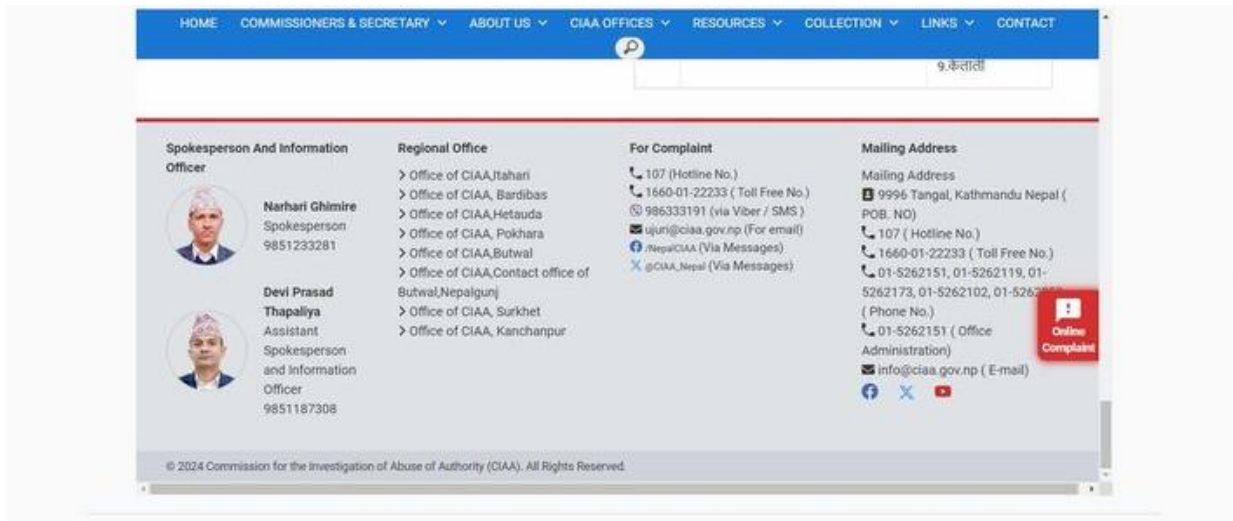


Figure 3: Complaint Filling

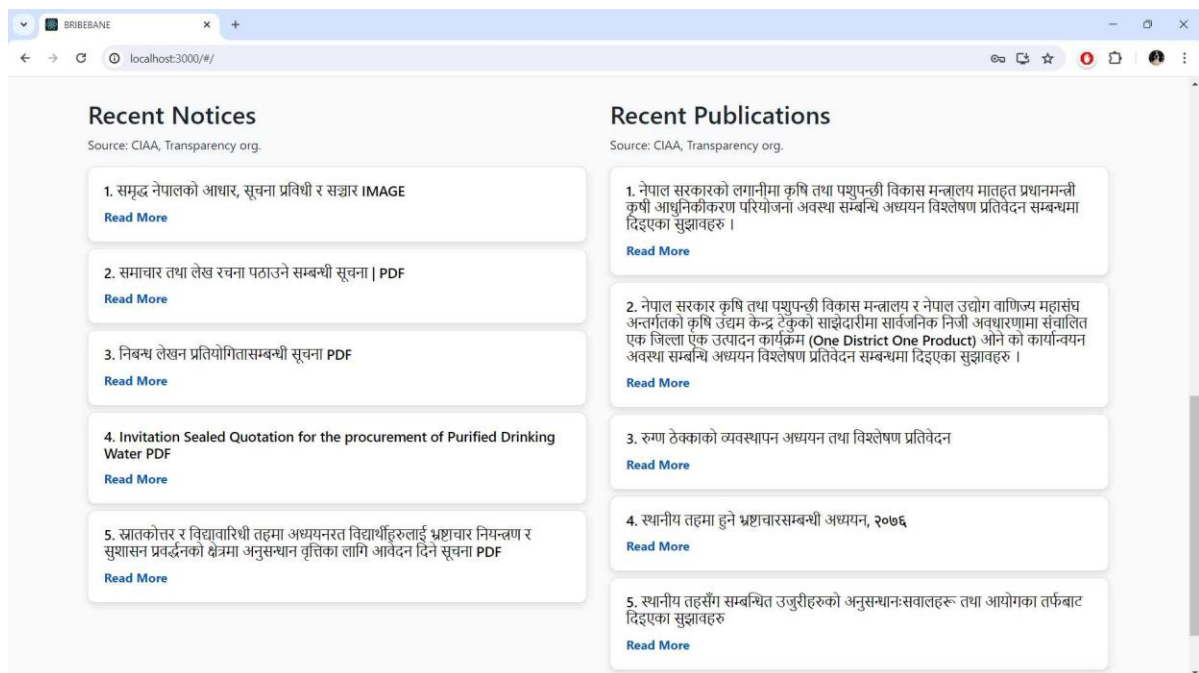


Figure 4: Recent News & Publication

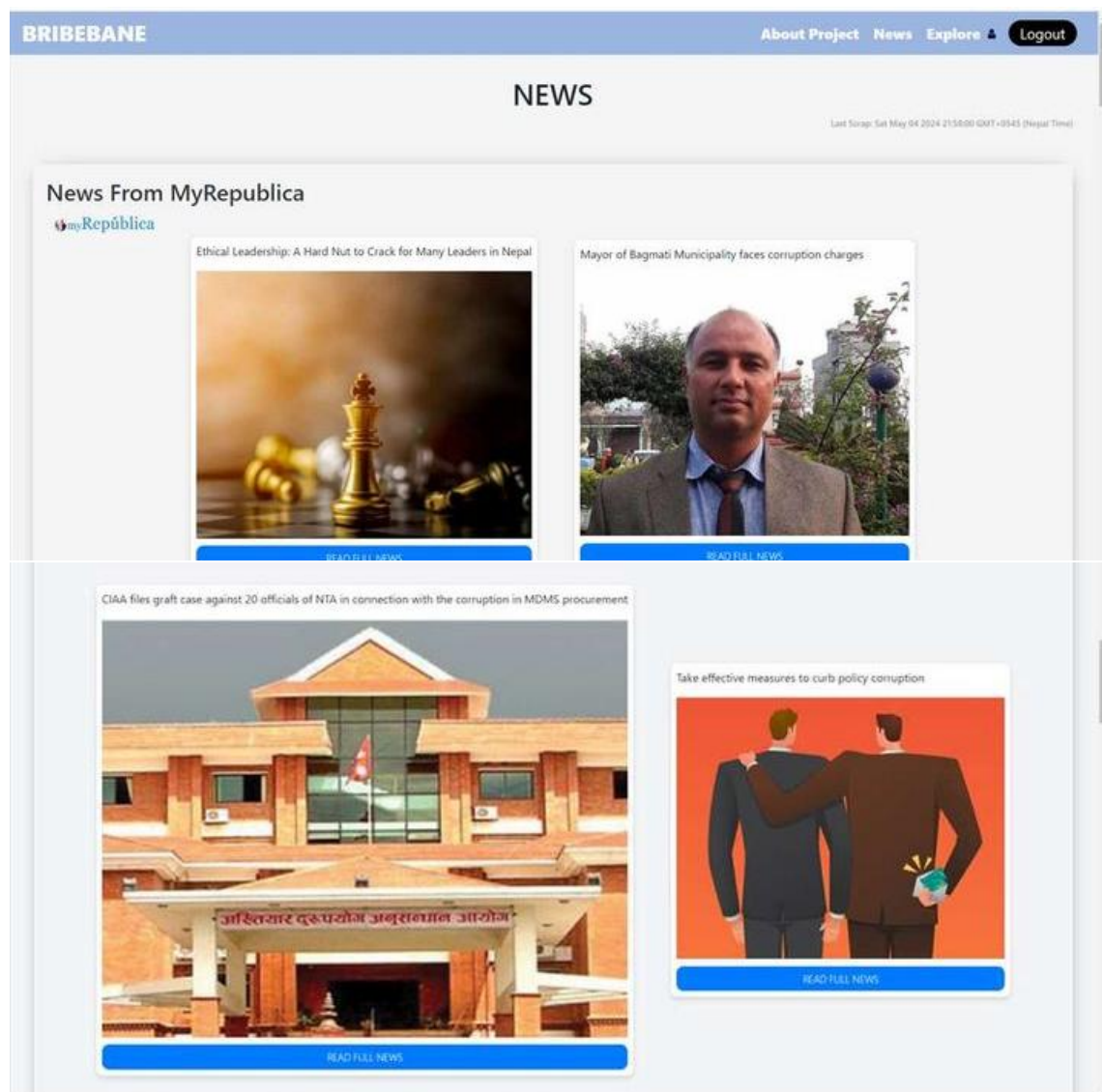


Figure 5: News Page
